





- They will assess the potential of the DAT solutions in addressing CBOs challenges



Key factors on which DAT solution providers will be assessed

- Innovativeness and scale of the DAT solution (product or service), including its measurable impact
- Relevance of the DAT solution to the six themes
- Past relevant experience of the enterprise in working with CBOs or government agencies within and outside Maharashtra

Shortlisted DAT solution providers will receive mentorship from a panel of experts
